### **PART 11 – ROAD OCCUPANCY PERMIT**

Permit fees charges according to the fee schedule established by the Pennsylvania Department of Transportation. A check deposit must be made to the Township escrow fund before a permit may be issued for opening and Township right-of-way. A properly executed and binding Performance Bond may be substituted for a check deposit, provided that the Bond coverage is equivalent to the required check deposit. (State Road-Penn Dot) Township Road-Township-Public Works Director.

#### **Fee for excavation within improved portion of the Right-Of-Way**

Residential - \$300.00/first 100 linear ft. \$1.00 each additional ft.

Commercial - \$300.00/first 100 linear ft. \$1.00 each additional ft.

Escrow - \$2,000.00

#### **Fee for excavation within the unimproved portion of the Right-Of-Way**

Residential - \$150.00/first 100 linear ft. \$1.00 each additional ft.

Commercial - \$150.00/first 100 linear ft. \$1.00 each additional ft.

#### **Escrow (Only applicable to improved portion of the Right-Of-Way)**

An escrow deposit shall be submitted with all street openings to guarantee the satisfactory restoration of the roadway, and other disturbed areas within the public right-of-way. The escrow deposit will be fully refundable only after an inspection had been conducted by an authorized township official to determine that the proper restoration has been accomplished. In the event that an inspection yields deficiencies in restoration of the roadway or other public improvements within the legal right-of-way, the township reserves the right to complete said restoration in a satisfactory manner. The applicant shall be responsible for any charges in excess of the original escrow amount. A 10% administrative charge will be added to all fees and costs. Any unused portion of the escrow deposit will be refunded to the applicant.
